- 5. If chosen, the Applicant will alter his/her design according to the Host's requirements. If the Applicant is not willing or fails to alter the design, other designers who finally complete the alteration will share the Applicant's eligibility and remuneration.
- 6. If the Applicant's design is chosen, the Host shall pay remuneration to the Applicant. If the Applicant fails to be chosen, the Applicant will not receive any remuneration, and is responsible for any cost occurring from designing.
- 7. The Host has the right to use, develop, authorize, license, or protect the winning design of the Applicant in any form, without interference from the Applicant, the original author or any third party. The Applicant will not share any rights or benefits as a result of the activities mentioned above.
- 8. If the Applicant fails to fulfill the obligations in this letter of commitment, and is unable to take effective remedial measures within 10 days after being informed by the Host of such a situation, the Host reserves the right to claim compensation from the Applicant.

9. The Applicant shall hold harmless the Host against all claims, litigation, arbitration,
losses, or damages to reputation caused by the Applicant. In such occasion, the Host
reserves the right to claim compensation from the Applicant.
